# **3.6 Building Canada Fund – Communities Component – Top-up**

WHEREAS the federal and provincial governments will make a one-time extension of the deadline for funding of projects under the Infrastructure Stimulus Fund and the Building Canada Fund – Communities Top-up from March 31, 2011 to October 31, 2011; AND WHEREAS all funding from the Government of Canada and the Province will cease after October 31, 2011;

AND WHEREAS the Town of Bay Roberts has asked the provincial government for an extension to the federal and provincial funding to October 31, 2011 for the following projects:

Project #26652 – Replace Sanitary Sewer Route 70 Eligible Cost: \$1,700,000 Federal Contribution: \$541,593 Federal Audit Cost: \$1,593 Project #26648 – North Road Lift Station and Forcemain Eligible Cost: \$2,550,000 Federal Contribution: \$812,389 Federal Audit Cots: \$1,593

THEREFORE BE IT RESOLVED THAT the Town of Bay Roberts attests that it will continue to contribute its share of the required funding for the aforementioned projects; AND BE IT FURTHER RESOLVED THAT actual claims for all eligible costs incurred by March 31, 2011, for the aforementioned projects must be and will be submitted no later than April 30, 2011 to the Province;

AND BE IT FURTHER RESOLVED THAT the Town of Bay Roberts will ensure that the project will be completed.
