Water & Sewer Availability – 230 Central Street – Committee has determined that services do exist to the southwest corner of the property however, if the property was to be sub-divided, extensions of both water and sewer mains would be necessary.

Capital Projects – Committee discussed the capital project priorities for 2011.

Arthur Dominix addressed Council. Mr. Dominix suggested to eliminate any liability on the Town by offering to rent the road for a minimal cost and a flag person free of charge to perform road upgrades to Jack's Hill on Country Road. Mr. Dominix further expressed his concern and disappointment with Council's decision to not carry out road upgrades to Jack's Hill on Country Road.
