Mayor Sparkes asked if there were any errors or omissions to the minutes of October 26th, 2004, which has been circulated in the agenda.

It was moved by Councillor Greenland and seconded by Councillor Brown that the stipulation be struck out and the new motion is to state that approval be given to Batten's Warehouse Limited for the placement of a portable building to be situated on their property adjacent to the existing Batten's Retail Outlet, subject to all other regulatory departments. Motion Carried.

Councillor Greenland advised that Mr. & Mrs. Everett Mercer would like to discuss with Council the issue surrounding a letter which was presented to Ms. Kim French.

D. M. Littlejohn advised that he had spoken with Mr. & Mrs. Mercer and they were satisfied with the results of the investigation carried out by Mr. Delaney. However, D. M. Littlejohn will contact Mr. & Mrs. Mercer again to confirm this.

Councillor Brown inquired if Mr. John Moore, Dept. of Municipal & Provincial Affairs, has been contacted regarding pension allotment for Council members. D. M. Littlejohn will continue to seek information regarding this matter.

Councillor Greenland inquired if Mr. Geoff Atkinson has been contacted regarding clean up of his building on the corner of Neck Road and Love Street. Town Manager is still looking into this matter. Councillor Bowering asked to go on record to say that in reference to the Batten's Warehouse Limited application, he does not want to turn off any potential business from our Town, however, he would like to see an expedient clean up of the Batten property.

It was moved by D. M. Littlejohn and seconded by Councillor Seymour that Mr. Coombs be advised that the area in question is beyond municipal control and that he should contact the Dept of Agriculture and/or Crown Lands regarding this matter. Motion Carried.

Sketch received from Norman & Parsons Surveys Ltd.showing a compiled view of the beach area in front of the Gus Fitzpatrick and Wayne Parsons Arney's Pond Road properties, along with the armor stone retaining wall and the high water line as of September 24th, 2004.

It was decided that the Town Manager will contact the proper authorities to determine the accepted boundary for the high water mark and the reservations required around oceans.
