Further, the Collection Policy is to include a sliding scale of interest that we are will to write-off for lump sum payments of entire balances of tax accounts.

Payment in full on balances with 2 or more years outstanding and balances as follows:

Up to \$10,000	20% of interest
\$10,000 to \$20,000	30% of interest
\$20,000 to \$30,000	40% of interest
\$30,000 to \$40,.000	50% of interest
\$40,000 to \$50,000	60% of interest
\$50,000 plus	70% of interest
