EARLY PAYMENT DISCOUNT

A 5% discount will be applied to residential 2023 taxes (not commercial) if paid in full by March 31, 2023 and provided that all previous taxes have been paid. The discount date will not be extended.

SENIORS DISCOUNT

Seniors (65+) will receive an additional discout of 5% if taxes are paid in full by March 31, 2023. Age verification will be required to receive this discount. Senior Receiving the Garanteed Income Supplement under the Old Age Security Act may apply to the Town for an extension of the combined discount (forms are available at the Council Office).

INTEREST

Interest will be charged at the rate of 0.5% per month (simple interest) on all past due taxes prior to 2023.

PAYMENT DUE

All property, business, water and sewer taxes are due on or before June 30, 2023.
