- That there are two curb stops, servicing 9 and 12 Fox Place Extension and accesses to these curb stops is permissible by Town Staff.
- That the property owners of 12 Fox Place Extension are responsible for the repair and maintenance of the water service line from the original curb stop to each curb stop servicing 9 and 12 Fox Place Extension.
- That no addition development will be permitted from this road/cul de sac.
- That the developers provide a survey of the road and cul de sac at the developers' expense with the exact dimensions to confirm extent of ownership.
- If the unit is ever sold, it is to remain a single residential dwelling.
