Motion 2025 – 1273 Deering/Franey

Resolved, that Council give an Approval to Borrow from the Bank of Montreal for a 5 year fixed rate with a 10 year amortization, 4.45% interest rate, loan amount \$137,331.47 for the purpose a 2024 Capital Purchase of a Stage and Ramp as per the Budget 2024. The monthly payment will be \$1419.97

Approval to Borrow Request Motion 2025 – 1274 Franey/Bowering

Award – Contract for Intersection Upgrades

Resolved, that Council award the contract for the Intersection Upgrades for Shearstown Road and Conception Bay Highway to Black Diamond Construction Limited in the amount of \$892,411.50 to complete the project in 2025. Carried Unanimously

Special Assistance Grant (SAG) Application – ApprovalMotion 2025 – 1282Franey/Bowering

Resolved, that the Town apply for the Special Assistance Grant (SAG), Department of Municipal Affairs for upgrades to electrical at the Bay Arena and at a cost sharing arrangement of 60% Province and 40% Municipal. The maximum the Town would pay is \$12,000 which is budgeted in its 2025 Operating Budget.
